	3.1 City of Thunder Bay Emergency Task Force Update	<ul style="list-style-type: none"> 11 cases will be announced today. 10 VOC's in the city. Ontario's cases are overall exceeding past covid waves. Things may be stabilizing over the next 7 days. Of all the positive cases in Southern Ontario, 90% are the UK variant. Over the next couple of days, a survey will be coming out to all essential workers to provide numbers on outstanding vaccines. 54,329 vaccines have been administered within the Thunder Bay District Health Unit, 48,000 of those are 1st dose, 8,850 per week are administered. As of May 1st, 40% of the Thunder Bay District Health Unit catchment will have received the 1st dose. April 11 – April 17 4,920 received the Moderna vaccine, 3,069 received the Pfizer vaccine, and 861 received the AstraZeneca vaccine. Johnson & Johnson has a one-dose vaccine that the TBDHU is planning to give to the vulnerable population as it is difficult to track them down after the 1st dose. 		

		<ul style="list-style-type: none"> Thunder Bay Regional Health Sciences Centre is at 80% capacity with 12 positive cases and 2 in ICU. Restrictions to non-elective surgeries has been put back into place. TBRHSC at one point was sending covid patients to the GTA. Now, the GTA might be sending patients back to TBRHSC. 24 individuals currently in the isolation shelter for the vulnerable population, 3 have tested positive.

	3.1 City of Thunder Bay Emergency Task Force Update	<ul style="list-style-type: none"> There was a rise in Covid numbers relating to a cluster outside of the TBDHU catchment area. This was a group of younger individuals in a long-term care setting. These individuals were identified through the surveillance testing and were able to stop the spread. Currently 61 active cases with 11 new cases which will be announced today. As of May 29, there are 104,078 vaccines administered. Of those, 87,563 received their 1st dose, and 16, 586 have been fully vaccinated. The TBDHU has reported 53.8% have been vaccinated. Over 60% of the population has received at least the 1st dose. 70% of those in the age range of 69 and up have been vaccinated. From May 23 to May 29, over 2,000 individuals received the Moderna vaccination and 6,101 have received the Pfizer vaccination. Those who received the 1st dose of the Astra Zeneca vaccination can get either the Pfizer or Moderna vaccination as their 2nd dose. The city is looking to set up a vaccination clinic at the County Fair Plaza and possibly the Limbrick area. 		

		<ul style="list-style-type: none"> • Travel policy is being reviewed. People need to continue to follow the recommendations and be cautious when travelling, to self-monitor and isolate if need be. • The Delta Variant from India is spreading in the Toronto area. • Thunder Bay Regional Health Science Centre is at 80% capacity with 9 Covid cases and 4 of them from Manitoba. • For those who work in long-term care setting, vaccination may be mandatory. For those who do not want to get vaccinated, a 3-step processes might be required. Individuals may be required to obtain exemption from a doctor and take training on Covid protocols. • Health Care Workers and First Responders will be able to access before and after school care once the school year is complete. • 7 individuals are in the isolation shelter.

The College will announce on September 9, 2021 information with regards to the rapid antigen testing. 		

		<ul style="list-style-type: none"> • This testing will be conducted through Oak Medical. They have four locations available throughout the city. • Tests will be required every 7 days • Trying to set up locations in the region for rapid antigen testing. If there is a Shopper's Drug Mart in the regional location they will be done there. If no Shopper's is available, Mike is working with smaller pharmacies to have the testing available – more to come. • Residence is using Synergy Gateway for students submitting their vaccination passports. Students in residence will be required to submit to the Safe Campus app as well. • Thanks to those who reviewed and suggested changes and/or updates to the Covid-19 training • Mike is looking for 2 volunteers to go through the training and review it before it is re-released to the College community. Email Mike if you can help out. • Mike indicated no volunteers came forward • There will be 3 vaccination clinics held on campus, September 7 at Sibley Hall, September 8 in the Shuniah Building, Student Commons and September 16 in the McIntyre Building

He shared the LEC would like to follow up with this concern and exclusion of the Health & Safety committee as well. • Mike shared that nothing has changed with the Task Force other than their involvement in the vaccination policy finalization. We were given a very short window of time to get things done. There was no time to convene a meeting. Documents arrived from the Ministry on Friday September 3, 2021 end of business day and had vaccination policies had to be in place Tuesday September 7th, 2021. There was no time to consult. • Mike shared that the plan we implemented when Covid first started will serve us well if the variant becomes more concerning. We can move fluidly within our pandemic plan • Brenda shared that there is a review taking place on who is coming to campus. The plan is to have as many people as safely possible on campus. There is discussion around what 'front facing or student facing' means. If people have their own offices/space and are able to be properly distanced, then they are expected to work from campus.
